Q1. WHERE IS MAX VISTA ABAKALIKI LOCATED?

A Max Vista Abakaliki is a prime piece of land situated at Goodluck Ebele Jonathan Boulevard, Ohaebia idembia Isieke in Ebonyi LGA, Ebonyi state.
