### FREQUENTLY ASKED QUESTIONS/TERMS AND CONDITIONS OF PURCHASE

#### Q1. WHERE MAX COURT, MARKUDI LOCATED?

A MAX COURT, MARKUDI is a choice parcel of land strategically situated Mbamar community welfare quarter extension, markurdi. Applicants or their representatives are advised to inspect the site as the company shall not be held liable for claims/issues arising from client's failure to inspect the said property before purchase. Free inspections hold Mondays to Saturdays, from 10 a.m., and Sundays on special arrangement.

#### Q2. WHY SHOULD I BUY MAX COURT, MARKUDI?

A MAX COURT, MARKUDI overlooks the expressway and enjoys proximity to major commercial investment and landmarks such as, 5 miniate away from air force aviation school, 5-minute drive away from ikpayongo market, 10minutes drive away from federal housing estate. ### Q3 WHO ARE THE OWNERS/DEVELOPERS OF MAX COURT, MARKUDI?

#### Q4. WHAT TYPE OF TITLE DOES MAX COURT, MARKUDI HAVE?

A Survey and Deed of Assignment. The company has the long-term responsibility to ensure/facilitate further perfection of the estate's title subject to subscriber's payment of title perfection fees to be determined and communicated at a future date.

#### Q5. ARE THERE ANY ENCUMBRANCES ON THE LAND?

The land is free from every known government acquisition or interests and adverse claims.

#### Q6. WHAT IS THE PAYMENT PLAN?
