## FREQUENTLY ASKED QUESTIONS/TERMS AND CONDITIONS OF PURCHASE

## Q1. WHERE IS MAX GARDEN CITY, ABEOKUTA LOCATED?

A Max Garden City, Abeokuta is a prime piece of land situated at Akinosi and Kuole Orile olowu community, Aiyetoro Abeokuta. Applicants or their representativ s are advised to inspect the site as the company shall not be held liable for claims/issues arising from client's failure to inspect the said property before purchase. Free inspectons hold Mondays to Saturdays, from 10 a.m., and Sundays on special arrangement.
